#### Item 1.01. Entry into a Material Definitive Agreement

On July 31, 2008, Thorium Power, Ltd. (the "Company") entered into Amendment No. 1 ("Amendment No. 1") to an Agreement for Ampoule Irradiation Testing in 2006-2007 (the "Agreement"), dated December 28, 2007, between the Company and the Russian Research Centre Kurchatov Institute, a Russian Federation federal state institution ("Kurchatov"). Pursuant to Amendment No. 1, the term of the Agreement is extended from August 31, 2008 to December 31, 2008. All other terms and conditions contained in the Agreement remain unchanged and in full force and effect.
